CLAUSES ACTIVITY - ANSWERS

Contract Receipt and Review (CRR)

Access and read the specific clauses that will be helpful with CRR. Write your answers in the space provided for future reference and discussions during the Networking Learning Forum. Note: These are not ALL clauses to consider, just a few of the most common.

- 1. Read <u>Combatting Trafficking Persons (CTIP) 52.222-50</u>. Summarize the clause section (b) *Policy* stated in FAR 52.222-50.
 - The United States Government has adopted a policy prohibiting trafficking in persons, including the trafficking-related activities of this clause and contractors, contractor employees, and their agents must adhere to this policy.
- Read Inspection Clauses 52.246-2. Explain how the FAR clause defines "supplies." Share
 any additional information contained within this clause that you found interesting. (a)
 Definition. "Supplies," as used in this clause, includes but is not limited to raw materials,
 components, intermediate assemblies, end products, and lots of supplies. The second
 answer will vary.
- 3. Read FAR 52.246-11 Higher-Level Contract Quality Requirement. This clause requires the contractor to use higher-level quality standards. What information does the contracting officer have to include in the contract according to this clause?

Title, number, date, and tailoring if required are completed by the contracting officer.

- 4. Read DFARs 252.246-7000 Material Inspection and Receiving Report. What must the contractor prepare and furnish to the Government and in which Appendix is this located?
 - At the time of each delivery of supplies or services under this contract, the contractor shall prepare and furnish to the Government a material inspection and receiving report in the manner and to the extent required by Appendix F, Material Inspection and Receiving Report, of the Defense FAR Supplement.
- 5. Read DFARs 252.246-7001 Warranty of Data clause and explain what the clause requires of the contractor per section (b) Warranty?
 - The contractor warrants that all technical data delivered under this contract will at the time of delivery conform with the specifications and all other requirements of this contract.
- 6. Read DFARs 252.246-7003 Notification of Potential Safety Issues. What is the contractor's responsibility when providing notification of safety issues?
 - The contractor has the responsibility of notifying the ACO and the PCO as soon as practicable, but not later than 72 hours after discovering or acquiring credible information concerning nonconformances and deficiencies.
- 7. Read DFARs 252.246-7007 Contractor Counterfeit Electronic Part Detection and Avoidance System. Under what conditions does this clause apply?
 - The contractor is subject to the Cost Accounting Standards under 41 U.S.C. chapter 15, as implemented in regulations found at 48 CFR 9903.201-1.
